Petition matter

- Change person exercising rights and obligations of underage child <u>Lo Yu-xiang</u> (born on September 26, 2017, ID card number:) to the petitioner.

Facts and reasons

- 1. Petitioner is father of underage child Lo Yu-xiang. Petitioner and respondent
 - ■agree to divorce on April 12, 2022. Both parties agree to share responsibility of exercising the rights and obligations of the underage child. However,
